Who we are

We work with European Christian Mission International (UK registered) and its mission partners throughout the world. We refer to that as the ECM network.

What is your personal information?

How do we use your personal information?

We will use your details in ways such as:

We will store your personal information only for as long as is appropriate for the relevant activity, or for as long as we are legally required to hold it in order to fulfil our statutory obligations (e.g. the collection of Gift Aid is subject to HMRC auditing up to seven years after donation).

We take appropriate action to make sure that your personal information is accurate, up to date and stored in a secure manner and only used for the purposes for which it was provided.

Will we share your personal details?

We will not sell, exchange, give or trade your personal information with third parties for marketing purposes.

On occasion we may pass your details on to our approved third party service providers in order to carry out tasks on our behalf (such as processing financial transactions, sending post and email, providing you with goods or services, fulfilling information requests or analysing data). Whenever we use third party service providers we only provide the minimum of information necessary and have a contractual obligation for the data to be processed in compliance with the European Data Protection regulations. In order to ensure the security of your donations, our secure online donation pages are processed by a third party payment processor specialised in this area.

We will not share your personal details outside the ECM network, except when required to for meeting a legal or regulatory requirement (e.g. Gift Aid). Those with whom we share your details may only use it to perform these functions and may not use them for any other reason.
